Subject: The Constitution's true basic intent at Law -- finally

A fundamental study into the Constitution that our people have not been told:

[RE: Preamble is "Ordained"](#)

I know you good Christian folks are concerned about events in our country and correctly realize that obedience to Yahweh our King is our only answer. I commend you all for that enthusiasm, and I agree. However, the two Saxon writings we have cherished as a people which the enemy has sought to destroy above all other documents have been first and foremost The Holy Scriptures, and second The Constitution For the United States of America.

The adversaries have done their dirty deeds to misrepresent the intent and meaning of BOTH these writings of our heritage, and so we find ourselves in the position we are today. Granted, the Constitution is not the foundation of our laws, that being God's Word. This alone however does not mean that the Constitution was not a result of God's circumstances in the 1700's, nor that The Almighty desires us to trash that American foundational document on the grounds that it supplants His Laws. There have been certain lawful contracts between men in the course of history which were "led of the Spirit" and had a great impact upon our western civilization. We may consider them as "tools" Yahweh has manipulated into our hands to help us work in His vineyard of our family Laws, His Laws. They do serve a divine purpose, and the original USA Constitution is one such example of the Divine Hand in history controlling circumstances.

The Constitution **IS** the willful administrative agreement by which God's Laws can be secured in our land. The Constitution has a divine purpose as a tool formed by authority of the Scriptures for godly men to enter into a compact (contract) to have order and not chaos in their lives. Just as Yahweh has guided decisions of ancient Israel Kings, so was His influence upon our Founding Fathers even though they were sinners as we are.

Constitutional critics have, unfortunately, mistaken the present ills caused by the present corrupt version of the Constitution which was changed by the unlawful 14th Amendment, as compared to the lawful intent written into the

original Constitution of 1787. I don't blame the critics' anger, but in their fury for what has happened to America they have been led astray from the truth concerning law, due to the incompetent presentations of that law by "leaders" who are simply mistaken. If cooler heads are given time to prevail, it is provable the original Constitution's intent at law is neither "evil" nor against Yahweh's Laws as some claim.

That original intent **IS** Scriptural and in fact the original USA Constitution is the precise method of administration that makes it possible for all of the (once) freehold people of America to live by Yahweh's Laws in their own private homes and private local communities. The Constitution does not have to list every one of Yahweh's Laws for it to be a divinely inspired document. What the Constitution does, if followed as purposed, is to give white Christian Americas the LIBERTY to be free in their own homes. Then it is up to the individual (or family) to study, learn, and apply Yahweh's Laws within their own kingdom – their homes. The original Constitution is Commonwealth law. Yahweh's Kingdom is now in the Christian Commonwealth as taught by the apostle Paul in Ephesians chapter two. The Scriptures tell us the story of how Yahweh's Kingdom administration was progressively transferred from Adam days in the Garden, then to the patriarchs, to the judges, then the Kings, then into the NT Commonwealth, with Christ as the ultimate King. This is why the banner of the Americans during the War For Independence was "No King but Jesus" while uniting in a Commonwealth system of law.

Now here is what our people **MUST** relearn about the Constitution instead of tossing it into the garbage heap due to not understanding it. The proper and lawful USA Constitution is a Trust Instrument declaring that **ONLY** "the posterity" referred to in the Preamble (who were Saxon Christians) could inherit the land and the freehold rights that go all the way back to Adam in Eden. **WE THE PEOPLE** are heirs to the liberty trust. "WE THE PEOPLE" was not an ungodly proclamation by the patriots to raise themselves above the Living God of the Scriptures, as anticonstitutionalists claim they were doing saying that the Founders were idolaters. Those early Americans were Christians who viewed themselves to be within God's pasture as His flock, and their writings reflected this belief repeatedly. "*For He is our God; and we are the people of His pasture, and the sheep of His hand.*" Psalms 95:7 They knew who their King was.

Not only were the Constitution writers Saxon Israelites declaring something divine in the Preamble (the **BLESSINGS** of liberty) that were to be handed down to their heirs of the racial posterity, but they carefully took great distinction in “ordaining” this document – “we do **ORDAIN** and establish this Constitution—“

Law is written in the language of any era so that the inhabitants of the land may understand it. Thanks to Bunny Speakman, an email friend, for pointing out to me the correct awareness concerning the deliberate usage of the word “ORDAIN” in the Preamble.

In order that the American Constitutional Founders would make it perfectly clear to the tyrants in England , what they (the Founders) were actually doing, the word "ordain" was used in the Preamble as an intentional choice of announcement. "Do ordain" defined the religious qualifications necessary to bring the Constitutional intent within the parameter of Henry's Statute of Uses, Elizabeth 's Statutes of Charitable Uses and the Statutes of Mortmain, as to make The Constitution a valid, legal document under the former English Laws that once followed righteous precepts of Scripture. As we see, good English law had been subverted, with the American Colonists bearing the brunt of abuse that resulted.

By ordaining the Constitution, the American Founders, were by the language of the day, establishing a lawful religious society of the Signers (all Saxon Christians of several denominations), and passing it down to the heirs, “their posterity” of the subsequent genetic families, and their racial kin who may join them in the new land. By this usage of words in the Preamble, the now free Christian Americans were following, whether they actually knew it or not, Yahweh’s spirit of the Law for Saxon Israel,

“And ye shall be unto me a kingdom of priests, and an holy nation. These are the words which thou shalt speak unto the children of Israel .” Exodus 19:6

The lawful word terminology in use at the time of the early American “Founders” conveyed this national “priesthood ordination” quite clearly. It also tells us why we call the Founding Father’s “the Founders”. Everybody has missed this point in our history but it is there nonetheless:

Blacks Law Dictionary: *"OrdainTo confer on a person the holy orders of priest or deacon. Establish ... Found."*

Webster's 1848 Dictionary: *"Ordain v. To set; to establish a particular office or order; hence, invest with ministerial function or sacerdotal (priesthood) power; to introduce and establish or settle in the pastorate office with the customary forms or solemnities; as to ordain a minister of the gospel. (1) In America , men are ordained over a particular church and congregation or as evangelist without the charge of a particular church, or as deacons in the episcopal church."*

By use of the specific word “ordain” in the Preamble, the Founder’s were telling a debauched England (and all the world) that the patriot’s .50 caliber muskets had established a free religious society on this side of the Atlantic Ocean and that their constitution applied only to the “heirs of freedom”, the posterity – another word of significance seen in the Preamble.

As it was then, early American law only mentioned “Constitutions” in light of a religious society. The term “religious society” simply meant then what our terms “fellowship”, “ministry”, or “assembly” mean today. And it is in this context that the word “Constitution” was used. The USA Constitution was never viewed as being secular or humanist in any manner whatsoever. Constitutional bashers today fail to comprehend the language as being used at the time of the late 1700’s.

D. 66 Am Jur 2d Religious Societies

1. *'7 Constitution, rules, and regulations. The Governing body of a religious society may adopt a constitution and prescribe rules and regulations as to the government of the society.....*

2. *'8 Amendment of constitution, changes in confession of faith: So long as not contrary to the laws of the land or to the provisions of the society's old constitution, the method of submitting proposed amendments to the constitution of a religious association may be devised and proclaimed by the association's general officers.*

3. *' Members, Generally; relationship and rights: The relations, rights, and obligations arising from membership in a religious society are to be determined according to the constitution, rules, or bylaws of the society, as*

well as by reference to the statutory provisions governing such religious bodies, since all who unite themselves to a religious body do so with an implied consent to its government and are bound by its laws, usages, and customs, and principles,..."

With that law of the era now grasped within our minds, what were the only fundamental “rules” “by laws” “ordained” for “the posterity” of the new American Constitution? Noah Webster, who wrote our first national dictionary pertaining to the language and laws of the land explained beyond doubt what the source of the original Constitutional intent was:

In 1832, Noah Webster, author of America’s first dictionary, published his ***History of the United States***, in which he wrote:

"The brief exposition of the constitution of the United States, will unfold to young persons the principles of republican government; and it is the sincere desire of the writer that our citizens should early understand that the genuine source of correct republican principles is the Bible, particularly the New Testament or the Christian religion. "The religion which has introduced civil liberty is the religion of Christ and His apostles, which enjoins humility, piety, and benevolence; which acknowledges in every person a brother, or a sister, and a citizen with equal rights. This is genuine Christianity, and to this we owe our free Constitutions of Government."

Therefore, considering the above “ordaining” of our American Constitutional government as a religious body, those who state that the 1st Amendment opened up the door to all manner of non Christian polytheistic rule in America are in error of the facts of law and clear language intent of 1787. In reality, what happened is that subverter of the original Constitution began to change things within one generation of its passage, but the fault is not to be found in the document, rather in the people themselves who left down their guard.

Moreover, if we are concerned about obeying Yahweh (and we should be), godly Constitutions and lawful national contracts between men down through the ages that are NOT possibly to be found in the Scripture writ itself, are to be obeyed, according to Yahweh’s “renewed covenant” laws of the New Testament. These don’t do away with the OT national laws, but expand them in a higher light. Though godly and virtuous Constitutions are

“rules of men”, we must submit to these contracts as expedient to good government. This is a commandment given us by Scripture, and it is by the wisdom of God that it is supplied to us. We’ve all read this verse before, but how many have really understood of what it speaks?

I Peter 2:13 *“Submit yourselves to every ordinance of man for the Yahweh’s sake: whether it be to (a) king, as supreme;*

14 Or unto governors, as unto them that are sent by him for the punishment of evildoers, and for the praise of them that do well.”

This does not mean to submit to wicked tyranny because Peter also said in Acts 5:29 *“We ought to obey God rather than men.”*

Before it was changed by unlawful amendments (just as the Bible has been changed by translators) the original USA Constitution was “ordained” as one of the righteous “ordinance of men” completely in line with Biblical principles, and we are commanded to submit to it according to Scripture warning against anarchy in our land.

On a higher spiritual plane of revelation, so that we may be guided correctly in discernment of what to follow or what not to follow, this latter day contract between men, the original USA Constitution, was prophesied in the Psalms to arrive in the **“set time” of 1787** to declare the land rights for regathered Israel . Scripture has well shown that the continental USA is the prophetic ZION of latter day regathered Israel . As I have laid out in the “e-series” America Bequeathed Parts 1,2,3 – the Constitution is a Trust Instrument based upon land distribution going back to Abraham and Adam in the Holy Scriptures.

The “set time” for this latter day declaration of favoring our final inherited land rights of the very dust of the soil is established by revelation in:

Psalm 102:12 “But thou, O Yahweh, shalt endure for ever; and thy remembrance unto all generations. v13 Thou shalt arise, and have mercy upon Zion: **for the time to favour her, yea, the set time, is come.**” v.14 **“For thy servants take pleasure in her (Zion’s) stones, and favour the dust thereof.”** (This is the land inheritance of the very soil "dust" upon which we stand)

In this (verse 14) these several Hebrew words numerically add up to **1787**, the precise year (the "set time") that the Founding Fathers signed the Constitution For the United (E)states of America, and ORDAINED the Freehold Trust within the Preamble for their Saxon POSTERITY.

God Almighty did not see fit to have written into His Book every single event, person born, statement of history, invention device (such as the modern firearms), mode of transportation, commentaries of scholars and/or clerics, etc. etc., that would occur down through all of history – as obviously the Scriptures would then be somewhere in the range of several billion pages long. He gave us His Laws for the family and nation --- then told us to be good stewards of the freehold lands He would give us as our people traveled across the globe. In being good stewards and husbandmen within our historical travels Yahweh God expected us to declare certain rules NOT specifically written down in His Word, as we apply our changing circumstances to His Laws. Yahweh expects us to make our decrees as rules or else nothing can be established or accomplished. *“Thou shalt also decree a thing, and it shall be established unto thee: and the light shall shine upon thy ways”*. Job 22:28 Yahweh did not say, I will decree --- but gave us a responsibility that YOU shall decree.

Simply because liberty loving men enter into a stated contract with each other, and that contract may not literally be found in the Scriptures, it does not follow that the contract is “evil” or “adding to God’s Laws”. For example, an agreement you may make with someone to paint your house is not to be literally found in the Scriptures, yet such an agreement is not “evil” because you think it to be just a “rule of man”. The Mayflower Compact, Magna Charta, American Colonial Charters, The Declaration of Independence, and The original Constitution For The United States of America are all examples of “good laws” that follow in pursuit of I Peter 2:13 *“Submit yourselves to every ordinance of man for the Yahweh’s sake:”* In layman’s terms this means “good laws, righteous laws, decreed by men faithful to the Creator/Father/Savior” regardless of their own petty differences of theological doctrine. No brothers and sisters, the original Constitution is not evil, it has just been misunderstood since its inception. The first generation of our Founding Fathers knew exactly what it was, and it is time for us to relearn what they knew. They had it right. Blessings to the remnant --- Ken Lent
